

2019 EVERYWOMAN EXPO - FLOWER WALL (SNAP AND WIN) COMPETITION

TERMS & CONDITIONS OF ENTRY

1. Information on how to enter the Competition forms part of these terms and conditions of entry. Participation in this Competition is deemed acceptance of these terms and conditions of entry.
2. This Competition is being run at the 2019 EveryWoman Expo (21 Mounts Bay Rd, Perth WA 6000) during the Promotional Period.
3. The Competition is organised by Exhibitions and Event Australia (Level 1, 801 Glenferrie Rd, Hawthorn, VIC 3122).
4. The Competition commences at 9:00am Friday the 21st of June, 2019 and concludes at 6:00pm on Sunday the 23rd of June, 2019 ('Promotional Period').
5. Officers, employees and immediate families of officers and employees of the Promoter, the associated companies and contractors of the Promoter, retailers at the Centre and any other agencies associated with this Competition are ineligible to enter.
6. Competition open to entrants 18 years of age or over, or they must have an appropriate adult complete the entry mechanic for them.
7. Number of entries: Multiple entries per person.
8. People may enter the Competition by taking a photo in front of the Flower Wall (located in the Foyer, outside the Expo), uploading it to Facebook or Instagram account and tagging the EveryWoman Expo Facebook (@everywomanexpos) or Instagram page (@everywomanexpo).
9. Entries must be completed online during the Promotional Period.
10. The total prize is valued at \$500 and will consist of items from exhibitors at the 2019 EveryWoman Expo ('the Prize').
11. The winners of the Competition will be: determined by the most creative/innovative post.
12. The draw will take place at 3:00pm on Friday 12th July 2019 at the Exhibitions and Events Australia Office. The Promoter reserves the right to draw additional reserve entries and record them in case of an invalid entry or ineligible entrant is drawn. The winner need not be present at the draw.
13. The winner of the Prize will be notified by comment on their entry, followed up with a private message on Facebook or Instagram within two business days of being determined. The name of the winner may also be published on the Expo's Facebook and Instagram profiles within two business days of being determined. The winning photo may also be posted on the Expo's social media sites.
14. The prize will be delivered to the winners home address within one month of being announced.
15. The Prize awarded may not be exactly as illustrated in displays or marketing for the Promotion.
16. Unless otherwise specified, Prizes or any unused portion of a Prize, are not exchangeable or transferable and cannot be redeemed for cash.
17. If any prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize with a Prize equal to the value and/or specification, subject to any written directions from a regulatory authority.
18. The Promoter reserves the right to verify the validity of entries, prize claims and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry or prize claim that is not in accordance with these terms and conditions or who tampers with the entry process. An entry that is incomplete, indecipherable, illegible or non-compliant with these terms and conditions is invalid and will not be accepted or considered. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
19. The Promoter's decision is final and no other correspondence will be entered into.

It is a condition of entry that the entrant consents to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner of a Prize (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of the Competition (including any outcome), and promoting any products and services, distributed and/or supplied by the Promoters in the Expo(s) or otherwise.
